FIELD SIZE

• 32 Players. All players guaranteed three matches. This will yield 8 PODs of four (4) players. Each player will play all three other players in their POD (see schedule below). The winner of each POD will advance to an 8 player single elimination match play bracket.

Registration Opens: February 15, 2024

Early Entry Registration Deadline: Wednesday, May 1 at Midnight

Early Entry Qualifying Fee: \$20 (plus applicable golf/cart fees at qualifying site)

Qualifiers pay an additional \$120 to play in the Championship.

Final Registration Deadline: Saturday, June 1 at Midnight

Final Qualifying Fee: \$30 (plus applicable golf/cart fees at qualifying site)

Qualifiers pay an additional \$120 to play in the Championship.

Exempt Player Entry Fee: \$140 (Deadline May 1 - No qualifying necessary)

Tournament Information

FORMAT

- Women's Championship: 32 Players (WGC Match Play format)
- 8 PODS of 4 players
- All players compete against each of the other 3 players in their POD
- Winner of each POD advances to a single elimination bracket

SCHEDULE (Starting Times: Beginning at 7:00am each day)

- Friday (7/12): Day 1 of POD Play (2 Matches)
- Saturday (7/13): Day 2 of POD Play (AM) and Quarterfinals (PM)
- Sunday (7/14): Semifinals (AM) and Finals (PM)

SEEDING and POD ASSIGNMENTS

- 32 players will be seeded 1-32
- Defending Champion seeded #1
- Exempt players seeded next based on 2023 SDGA performance
- Qualifying players seeded based on qualifying score
- Each POD consists of one player in each group drawn at random
 - Seeds 1-8, Seeds 9-16, Seeds 17-24, and Seeds 25-32

MATCH SCORING in POD PLAY

- Match won = 1 point / Match tied = ½ point / Match lost = 0 points
- No extra holes played to break a tied match
- Ties for winning a POD will be resolved first by the head to head record and then by sudden death playoff among all players tied

PAIRINGS

- POD play will be in foursomes (2 matches per pairing)
- Each match will have different players from other pods so each player will have a unique group for all three POD rounds.
- Bracket play will be in twosomes

PRIZES

- Trophies awarded to the Champion and Runner-Up
- Merchandise gift certificates are awarded to the Champion, Runner-Up, and all POD winners.

FIELD SIZE* - The final field size will be determined by the number of exempt players who choose to play in the event and based on the following:

- If the number of entries from exempt players is over 10, the field size will be 32 players unless there are less than 32 total entries.
- If the number of entries from exempt players is 10 or under, the field size will be 16 players.
- If the total entries (exempt and qualifiers) at the registration deadline is between 17 and 31, the SDGA will decide how to proceed and notify players immediately.
